Align Education to Address Gaps in the Workforce

- Create Bachelor of Science programs at community colleges to fill workforce gaps.
- Streamline the accreditation process for education programs that address workforce development.
- Support education and workforce policies that allow Dreamers and immigrants to gain greater access to the education system.

Bolster the Current Education System

- Support budget requests for public education and higher education.
- Incentivize careers in teaching and bolster policies to retain existing educators.

Increase Equitable Access to Academic Achievement and Work Readiness

- Invest in affordable, high-quality early education and child care programs.
- Fund programs that increase student enrollment, financial literacy, and digital accessibility.
- Expand wraparound care services for students in need of support.
- Reduce time and burdens for degree completion and transfers.
- Forge pathways for affordable higher education and skills training.

The Energy, Water & Environmental Sustainability Council focuses on advancing cost-effective policies and programs to ensure reliable and affordable water and energy delivery, improve air quality, promote economic growth, and address climate change in the Los Angeles region through the local development of technologies, businesses and jobs.

Advocate for Technology-neutral, Cost-effective, Reliable and Diverse Energy Supply

The Chamber recognizes that businesses must have an affordable, diverse and reliable energy supply for the regional economy to remain productive and competitive.

- Advocate for policies and funding that are inclusive of all energy sources, modernize our electric grid system to ensure reliability, and increase affordability.
- Work with members and policymakers to understand the options, feasibility and costs for investments in an alternative energy supply, including the related costs of integrating alternatives into the existing power systems.
- Support domestic energy production and further maintenance of the region's existing energy systems and supplies, including the integrity of our regional pipeline infrastructure.
- Support expediting infrastructure projects that support our diverse energy supply.
- Support modernization of wildfire response and liability as the state confronts a "new normal" given increased climate impacts.

Responsibly Implement Air Quality and Climate Regulations

The Chamber will work with local, state and federal environmental agencies and the Chamber's Transportation & Goods Movement Council to understand the availability, cost-effectiveness and feasibility of alternative fuels for the transportation sector to meet anticipated air quality standards in the region.

- Advocate for reasonable, cost-effective, and technologyneutral environmental policies at the local, state, and federal levels that achieve air quality goals while ensuring compliance and implementation of the South Coast AQMDs 2022 Air Quality Management Plan, CARB's 2022 Scoping Plan, and U.S. EPA environmental standards.
- Work with policymakers to ensure California receives sufficient funding from recent federal climate and infrastructure investments to adequately address air quality concerns in our region.
- Quantify and educate policymakers on the ongoing impacts of Assembly Bill 32 and Senate Bill 32 on the economy while furthering our commitment to address climate change and improve the environment and support our natural resources.



Secure Safe, Reliable and Affordable Water Supplies for Southern California

Securing a safe, reliable and affordable water supply is critical to the continued success of the region's economy. The Chamber supports the state's co-equal goals of providing a more reliable water supply and storage for California and restoring the delta ecosystem.

- Advocate for policies that protect California's long-term water security and are inclusive of all water sources increased storage, groundwater recharge, desalination, stormwater capture, etc. — as outlined in Governor Gavin Newsom's Water Resilience Portfolio.
- Support an appropriately sized Delta Conveyance project and work with the Metropolitan Water District of Southern California (MWD) and other stakeholders to ensure the project meets milestones for its subsequent construction.
- Identify feasible and cost-effective augmentations to imported water and secure the long-term water quality and supply of the region.
- Support key drivers for local water security such as existing infrastructure investments as well as Los Angeles Department of Water and Power and MWD shared objectives of maintaining existing infrastructure and enhancing the diversity of the region's water supply resources (recycled water, stormwater, conservation, mitigation and remediation efforts).

- Advocate for federal and state funding and work with policymakers to streamline permitting so that water infrastructure projects can reach the construction phase quickly.
- Monitor water quality regulations at local and state levels to ensure compliance.

Strengthen Los Angeles' Position as a Global Leader of Clean Technology Innovation

California is a global leader in clean technology innovation and sustainable business practices. The Chamber will advocate for economic strategies to grow the region's clean technology sector.

- Pursue state and federal funding opportunities, streamline government processes to foster innovation, and work in conjunction with local organizations.
- Continue to advocate for funding opportunities for the region from the Infrastructure Investment and Jobs Act and the Inflation Reduction Act.
- Increase collaboration among private, public and academic sectors, including with the Los Angeles Cleantech Incubator and PortTechLA.

The Government & Fiscal Affairs Council (GFA Council) serves as the Chamber's primary committee to evaluate legislation and policies that broadly affect the business community and civic life, including business regulations, government reforms, budgets, taxes, election procedures, inclusion and public safety. The GFA Council will work to ensure underrepresented communities do not experience acts of violence, opportunity and resource inequities, and institutionalized racism. The GFA Council will support policies and programs that break down barriers to change, provide fair and equitable access to economic and safety opportunities, and encourage community collaboration and inclusiveness.

Review and Recommend Positions on Local and State Initiatives

The GFA Council reviews proposed local and state ballot initiatives and recommends positions to the Chamber's Board of Directors. The council will continue to review these measures to ensure they are fiscally sound and do not negatively impact businesses in the L.A. region with higher taxes, new costs, or unnecessary regulatory burdens.

Good Governance and Fiscally Responsible Policies

The GFA Council will work to identify policies and take positions on business regulations to ensure they are fair and reasonable, foster good governance and promote fiscal responsibility. The council will advocate for prudent budgets and fair and consistent taxes in the city, county and state as well as oppose industry-specific taxes.

- Ensure accountability and transparency.
- Promote an equitable tax structure.
- Maximize investments, particularly for small businesses and underrepresented businesses.

Preserve Democracy and Protect Elections

The GFA Council will work to ensure a fair and open election process that is inclusive, convenient and userfriendly. The council will take positions on revisions to the L.A. County voting process and support election reforms that support, create or maintain inclusivity.

- Encourage maximum voter turnout and expand the use of mail-in ballots.
- Inform the business community of candidates' positions on issues of interest.
- Support redistricting efforts that promote appropriate representation of community and business interests.
- Support efforts to achieve a more transparent and inclusive governance model in L.A. City and L.A. County.

The Land Use, Construction & Housing Council of the Los Angeles Area Chamber of Commerce supports the adoption and implementation of planning policies that incorporate smart growth tools, drive economic growth, improve environmental sustainability, and enhance the quality of life and connectedness of our region.

Housing Production

The Los Angeles region is projected to grow by more than 400,000 new residents in the next 20 years, yet less than one-half of the needed housing is built annually. As housing demand continues to outpace supply, it is driving rents and housing prices even higher.

To tackle the existing needs of our communities and address the housing crisis, the Chamber will advocate for business-friendly incentives and opportunities to create more housing at all levels, cultivate healthier neighborhoods, and increase safety in our communities to make the region a more commuter-friendly place to live and work.

- Prioritize and advocate for workforce housing.
- Support efforts to streamline the CEQA process.
- Modernize the preservation of CEQA's original intent and prevent abuse for purposes unrelated to environmental protection.
- Streamline the appeals process and bring local regulations into compliance with state guidelines.

- Advocate for incentives for companies that provide and build affordable housing.
- Push for policies that ease the way for the construction of housing.
- Advocate for the City of L.A. to continue updating all planning documents, including community plans, to reflect pro-housing policies and develop more transitoriented communities.
- Support projects in the region that provide economic development in Los Angeles and ease the housing crisis.
- Ensure the region meets the challenges of population growth, diverse housing demands, and changing technologies, and also creates certainty for the development of our communities and residents.
- Support the statewide repeal of Article 34 of the California Constitution and increase affordable housing capacity for the City of L.A. as a backstop (SCA 2).
- Allow flexibility in providing affordable housing with market-rate housing developments.



Community Activation

The pandemic has affected our communities — and Downtown Los Angeles (DTLA) is no different. The concerns for public safety have discouraged Angelenos from visiting DTLA. The Chamber must work to enhance public safety to encourage residents and tourists to visit DTLA. The Chamber can work with nonprofits and other DTLA business organizations to collectively work towards re-engaging and revitalizing downtown.

- Support the development of community activation strategies across all issue areas, including education, housing, homelessness, and economic mobility.
- Support and ensure the goals of the DTLA 2040 Community Plan guide new development for the next 20 years.

Support Investment in Sustainable Goods Movement Infrastructure at the Ports and Along Goods Movement Corridors

Support the expansion and improvement of goods movement infrastructure and systems. Goods movement is the engine of the Southern California's economy and supports the supports the funding sources necessary for all modes of transportation.

- Lead and coordinate efforts at local, state, and federal levels for the funding and implementation of critical projects.
- Advocate for smart regulations that facilitate the effective and efficient movement of goods through our ports, such as zero-emissions trucks, charging and fueling infrastructure, and grid enhancements to ensure long-term reliability.
- Convene and work with policymakers and stakeholders on efforts to find a sensible and reasonable solution for the future of the I-710 corridor, taking into account the growth of goods movement while ensuring equitable opportunities and outcomes for communities along the corridor.

Support Continued Investments in our Region's Vast Infrastructure Network in Preparation for the 2028 Olympics

The historic investments provided by the federal Infrastructure Investment and Jobs Act (IIJA) provide a once-in-a-generation opportunity to rebuild Los Angeles into a world-class region. The Chamber will be a leader in building consensus among policymakers and stakeholders to ensure projects are built in a timely and cost-effective manner.

- Work with local agencies and elected partners to advocate for the region to secure its fair share of funding for new and ongoing projects while engaging our membership in the procurement process and other related business opportunities.
- Advocate for policies that streamline the permitting process, including CEQA reform, and lead to accelerated delivery of planned transportation projects. The Chamber will coordinate and lead efforts with public and private sector partners from project initiation through ribbon cutting.
- Build off past successes and plan a 2026 IIJA reauthorization strategy with partners and stakeholders.



Advocate for Sensible Environmental and Sustainability Policies that Promote Emissions Reductions While Promoting Economic Growth

One of our region's key competitive edges is its two ports — the Ports of Los Angeles and Long Beach. Their modernization and efficient operation are essential to maintaining our competitiveness on a global scale. Investment in both the federal and state freight plans will bolster our edge.

- Advocate for reasonable, cost-effective, and technologyneutral air quality regulations for the transportation sector, and ensure that regulations balance the environmental and economic needs of the South Coast Air Basin.
- Advocate and propose legislation and programs aimed at increasing zero-emission vehicles (ZEV) and ZEV infrastructure — including large commercial trucks and cargo handling equipment — across the region and country to reduce greenhouse gases from the transportation sector.

Support Expanding and Improving Southern California's Multi-modal Transportation Systems

The region's network of roads, transit lines, commuter rail, goods movement corridors, and ports of entry (both air and sea) provide the mobility and accessibility foundation to support the region's economy.

- Support transportation policies at all levels of government to increase mobility, relieve congestion, and expand alternative commute options.
- Work with local agencies and policymakers to identify opportunities for improving the safety and security of our region's transportation network.
- Promote equity in the implementation of the IIJA with a focus on providing opportunities for historically disadvantaged businesses to participate in the IIJA and other publicly-funded projects.
